Dear Mr. Cummings,

With reference to your letter 37/10, dated 20.4.37., regarding Hubert KESSELS, I very much regret that Hubert was, in error, written Herbert in our letter OF.22/5/DS.7a., dated 5.11.36.

At the end of 1935 Hubert KESSELS, on the recommendation of Adolf MAHR, the Ortsgruppenleiter in Dublin, was appointed Obmann of the Reichsverband deutscher Beamten (Head of the local branch of the Amt für Beamte) attached to the Ortsgruppe in Dublin. He was instructed in future to correspond direct with the Amt für Beamte of the Auslands Organisation through the Ortsgruppe Dublin. The Amt für Beamte, a Party organisation which has as its object the control of German officials abroad, was reorganised towards the end of 1935, when arrangements were made whereby the departmental groups of the Auswärtiges Amt (the German Foreign Office) were placed under its direction.

Apart from the above, we have received no further information regarding Hubert KESSELS since our OF.22/5/DS.7a., dated 3.11.36.
